# How do we collect your data?

You directly provide Ninatoka and TCM Connect with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Browse one of the Ninatoka and TCM Connect website pages
- Use the explore function
- Rate data
- Provide a comment to data
- Mark a notification as seen

Ninatoka and TCM Connect do not receive your data indirectly from any other source.

## How will we use your data?

Ninatoka and TCM Connect collect your data so that we can:

- Process your order and manage your account.
- · Allow you to log in
- Improve the quality of the provided data based on your ratings
- Prevent you from seeing the same notifications multiple times
- Analyze data associations such as conditions commonly searched for together to provide you with more insights
- Email you with special offers on other products and services we think you might like.

When Ninatoka and TCM Connect process your order, they may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

## How do we store your data?

Ninatoka and TCM Connect securely stores your data on a Neo4j server residing in Oregon, USA (us-west1), GCP.

Ninatoka and TCM Connect will keep your account and usage data as long as you have not deleted your account. Once you have deleted your account, we will delete your data by anonymizing your account. Your name and email will be removed from the database and any data resulting from your activity on our website.

## Marketing

Ninatoka and TCM Connect would like to send you information about products and services of ours that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Ninatoka and TCM Connect from contacting you for marketing purposes or giving your data to other members of the Ninatoka and TCM Connect Group (not applicable). You can do so via the unsubscribe function in any email you've received.

## What are your data protection rights?

Ninatoka and TCM Connect would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:
